1. 本月摄像头模组出货量保持快速增长,1-4月份累计出货数量约为5.184万颗 同比增长约22.2%.其中1300万像素及以上模组占比约为48%,较去年同期的约 12.8%大幅增长约35.2个百分点。

The shipment volume growth of camera modules maintained strong in April 2017. The cumulative shipment volume of the first four months was approximately 51.84 million units, representing a YoY increase of approximately 22.2%. Among which, the shipment volume of 13 megapixels and above camera modules accounted for approximately 48%, representing a YoY increase of approximately 35.2 pts as compared with 12.8% in the same period of 2016.

2. 本月指纹识别模组出货量同比大幅增长, 当季出货达到约680.2万颗, 较 2016年度4月的约33.6万颗大幅增长约1924.59%,较2017年3月的约599.7万 颗环比上升约13.43%。销售产品中盖板工艺产品占比约为30.58%.

The shipment volume of fingerprint recognition modules achieved significant YoY increase in April. The shipment volume amounted to approximately 6.802 million units representing a YoY increase of approximately 1924.59% and a QoQ increase of approximately 13.43%. Of which, products using the cover manufacturing know-how accounted for approximately 30.58% of the total shipment.
